### **The Inter-American Court of Human Rights announces the publication of several decisions translated into English**

San José, Costa Rica, June, 24 2020.-The Inter-American Court of Human Rights has made available the publication in English language of pivotal Judgements, as well as one Advisory Opinion, in an effort to improve the accessibility to its decisions for a wider global audience.

These translations represent a major opportunity for those responsible of the administration of justice, judges and lawyers, Human Rights Defenders, scholars and other key stakeholders worldwide, in order to have access to the jurisprudence and human rights standards developed by the Inter-American Court.
