### JOINT LAW REPORT 2019: THREE REGIONAL HUMAN RIGHTS COURTS



*San José, December 17, 2020.*- The African Court on Human and Peoples' Rights, the European Court of Human Rights, and the Inter-American Court of Human Rights launched their first Joint Law Report 2019. It integrates a selection of each Court's leading decisions in 2019. You can check the Report [here](#).

The Joint Law Report is a product of the Declarations of San Jose and Kampala. It is a first effort to present a single volume a selection of the leading decisions delivered by each Court in 2019. Since now, the three Regional Human Rights Courts will work to prepare every year a joint law report.

The Joint Law Report 2019 aims to be a useful tool for human rights legal practitioners in Africa, Europe, and Latin America.

This Joint Report is part of the activities planned in [Kampala's \(2019\)](#) and [San José \(2018\)](#) Declarations, which were adopted after the meetings between the three Courts. The Joint Law Report is a signal of the ongoing dialogue and work between the Courts.
