INTER-AMERICAN COURT OF HUMAN RIGHTS TRANSLATES JUDGMENTS AND ADVISORY OPINIONS INTO ENGLISH AND PORTUGUESE THANKS TO THE SUPPORT OF SWEDEN

San José, Costa Rica, May 29, 2024- The Inter-American Court of Human Rights with the support of the Swedish International Development Cooperation Agency (SIDA) has made available on its website the translation of 33 judgments into English. One judgment and one advisory opinion were also translated into Portuguese.

Through the project "Institutional strengthening of the Inter-American Court of Human Rights to optimize its capacities - Phase III" a key contribution was made to the dissemination of the Court's jurisprudence in English and Portuguese, allowing the translation of a total of 35 Court decisions.
