## I/A Court H.R. Protecting Rights

### **GABRIELA PACHECO ARIAS HAS BEEN APPOINTED DEPUTY REGISTRAR OF THE I/A COURT H.R.**



*San José, Costa Rica, May 31, 2024.* – In conformity with Article 14 of the Statute and Article 8 of the Rules of Procedure of the Inter-American Court of Human Rights, the Court’s Registrar, Pablo Saavedra Alessandri, has appointed Gabriela Pacheco Arias, from Costa Rica, as the new Deputy Registrar.

The Deputy Registrar has 21 years of work experience at the Registrar’s Office of the I/A Court H.R. She has held different positions during her time at the Court, including assistant attorney, senior attorney, International Cooperation Coordinator and Director of Monitoring Compliance with Judgments.

She holds a Bachelor's Degree in Public Law from Universidad de Costa Rica, an LLM in International Human Rights Law from Notre Dame University, United States, and a diploma in “Human Rights and Women: Theory and Practice” from the Human Rights Research Center of the Faculty of Law of Universidad de Chile.

In recognition of her trajectory, her commitment to the protection of human rights and to this Court, she was appointed Deputy Registrar of the Inter-American Court of Human Rights as of June 1, 2024.
